### **Teachers** demand safety

Members of all teachers' associations in Tirunelveli district, Tamil Nadu, protested to urge the government to enact a law to protect teaching service personnel and ensure their safety from violence and abuse.

On March 22, a brutal attack was unleashed on a headmistress and a teacher by a 2nd-grade student's parents in a village in Thoothukudi district, Tamil Nadu. The teacher instructed a student to sit before him because of his inattentiveness in class. When the student slipped and fell, his grandfather threatened the teacher, and the parents trespassed into the school, chasing the teacher down and thrashing him. unruly behaviour was caught on video and circulated on social media, prompting police action against them.

Sam Manickaraj, a government school official, said, "Government school teachers in rural areas are now worried for their security after the attacks; so to ensure their safety and to avoid more attacks on teachers, they started the protest. The goal of the protest is to pass a 'teachers' protection law. We have requested the teaching personal protection policy from the government." He added that teachers would feel safer knowing that the law protects them.

#### Tax regulations undergo overhaul

With the government coming up with a new system of pre-filled tax returns for small taxpayers and individuals, the taxpayers need to double-check the information on their tax returns and make sure that all income, deductions and exemptions are accurately reported, said Vagish CM, an official from the Income Tax Department.

New income tax regulations will come into effect on April 1st, and it's expected to bring major changes to India's tax-paying system. To streamline the tax code and boost taxpayer compliance, Indian government has made several changes. "To encourage saving and investment, the government has also introduced several new tax deductions. There are two of these: A deduction of up to 1.5 lackh for investments in certain long-term infrastructure bonds, and a deduction of up to 2.5 lahk for contributions to the National Pension System," said Vagish.

He further said that the goal of the new income tax laws is to increase the effectiveness of the tax system and make it simpler for taxpayers to comply with. The government hopes that the reforms will ultimately result in greater compliance and increased tax revenues, which can be used to finance essential public services and infrastructure.

## A collaboration for innovation

shared with the audience the journey of how SJU and Eurofins collaborated to set up an Advanced Analytical Chemistry Laboratory on campus.

Fr Dr Xavier explained how Arun Kumar, an employee of Eurofins, put forward the information about the Eurofins lab, which brought the first piece of good news to SJU. This led the way for the university to be equipped with top-notch laboratory facilities.

"The three individuals, Dr Victor Lobo, the Vice-

Chancellor, Fr Denzil E Lobo, the Pro-Vice chancellor, and Dr Melwin Colaco, the Registrar came together and took various paths to bring in Eurofins and make the collaboration a big success," added S Xavier.

As soon as the institution received approval from Eurofins, the MOU was signed within 15 days with the assistance of Fr Joy Rodrigues, Secretary and Treasurer of the Bangalore Jesuit Educational Society (BJES), he added.

## Agrarian infra to combat poverty

Campus: The agriculture industry is one of the most significant industries in the world, and it can be a catalyst for economic advancements. Along with trade liberalisation, the upgrading of irrigation networks and rural infrastructure usher in sustainable economic development, said Dr Cao, the former minister of agriculture and rural development of Vietnam and a renowned scholar. agricultural

On March 29, Dr Cao delivered the fourth Foundation for Agrarian Studies (FAS) annual public lecture at the

SJU campus. The lecture, copresented with the International Research Institute, focused agricultural management sectoral while emphasising policy development and application in Vietnam.

In a bid to combat hunger, poverty, and malnutrition underdeveloped nations, the FAS has been working tirelessly since its establishment in India. The organisation's annual public lecture series, which began in 2003, has provided a vital platform for discussions on agricultural studies, said Cao.
