Students to get free commute

<u>Sonia Sebi</u> he Kerala Motor Vehicle Department (MVD) announced free student transportation economically for disadvantaged families. Adarsh, a retired Road Transport Officer (RTO) of the Kochi Metropolitan Transport Authority, speaking to The Beacon, said the aim was to ease the financial burden on students who can now travel free of cost in Kerala State **Road Transport Corporation** (KSRTC) and private buses.

The rise in private vehicles has led to a decline in commuters travelling in public transport. The initiative aims to make public transport more appealing to all income groups by being efficient, affordable and a potential solution to traffic congestion, he said.

While private bus operators expressed concerns about incurring losses, Adarsh suggested a balanced approach. "They shouldn't be ignored completely. Initiatives that support both governments, as well as private sectors, should be undertaken. On the flip side, private bus operators should also recognise that allowing students to become accustomed to public transport usage, they are likely to foster a longterm preference for such transportation methods in the future."

A total of 64,000 financially disadvantaged families' students are expected to benefit from the free transportation scheme.

Khushbu Sundar favoured the current government's

South first approach to delimitation and its necessity for the southern states. The prime minister is actively working on it, and the focus will not be solely on population aspects, she said. Prof MV Rajeev Gowda voiced concern that the delimitation exercise should not lead to political marginalisation. The southern states are an integral

part of the federal equation. and sharing resources and increasing tax revenue should be done in consultation with other states, he added.

DK Shivakumar, Deputy Chief Minister, discussed the brand Bengaluru campaign mentioning the city's unique characteristics. Despite not being a planned city, Bengaluru has attracted people from around the world due to its pleasant weather, rich culture, abundant human resources, and educational opportunities, he said. "Bengaluru, the Pensioners Paradise, attracts tourists, and businesses, and provides a favourable environment for startups," he noted.

He also addressed issues that Bengaluru faces such as migrant housing, encroachment of lakes, congestion pricing, and healthcare. He emphasised that the development of Bengaluru is a collaborative process, and he would bring about significant changes within a year.
