ourism in Maldives is all set to take a . hit as the recent controversy is fanned further by several celebrities with many pegging the remarks of Maldivian ministers as outright racist, In 2023, Maldives witnessed 2.1 lakh Indian tourists on its islands, ranking first, followed by with the Russians and Chinese. Tourism holds immense economic significance in the Maldives, contributing 20% directly and a substantial 79% indirectly to the GDP, as noted by Elizabetta Gentile of the Asian Development Bank. According to World Bank data, factors like the lack of fiscal reforms, high public debt, increasing national borrowing, and environmental threats amplify the challenges for long-term sustainability.

Recently, Maldivian Deputy Minister Mariam Shiuna's criticism of PM Modi's promotion of Lakshadweep triggered a social media storm on X. Maldivian citizens labelled India's "Atmanirbhar Tourism" move as "delusional," leading to a wave of tour cancellations by Indian tourists with calls of 'Boycott Maldives' and 'ExploreIndianIslands' on social media platform. The controversy prompted over 500,000 Google searches about Lakshadweep in a single day. While three Maldivian ministers faced suspension for making derogatory comments, the recent dispute raises concerns given the World Bank's caution about the nation's vulnerability due to heavy reliance on tourism.

The current dependence on tourism exacerbates these issues, and potential mass cancellations by Indian tourists pose a significant risk to economic stability.

Teffrey Epstein's case file has become one of **J** the most sensational cases in recent American history. It is not without the typical badge of the modern social media era namely rampant misinformation and insinuations about celebs.

On 18 December 2023, District Court Judge Loretta A Preska ordered the unsealing of documents about the Giuffre v. Maxwell defamation lawsuit dating back to 21 September 2015. The plaintiff, Virginia Giuffre was one of the alleged sex trafficking victims of Ghislaine Maxwell (defendant) and her long-term partner Epstein. The court files were subsequently unsealed in batches from January 3-5 2024, now dubbed the 'Epstein list'. So far about 200 documents have been released with many more yet to be released. The documents outline how Epstein, an American financier,

island and around the world. Epstein was known to have connections with politicians, billionaires and academicians. High-profile names mentioned in the files included: Bill Clinton, Donald Trump and Prince Andrew. However, it

is important to note that the documents include no new names concerning Epstein's criminal activities. Some names remain redacted as it is currently under review. The documents were

rumoured to contain the names of Epstein's partners in crime. Due to this, many individuals have been wrongfully

News Week implicated, including Stephen Hawking, Leonardo DiCaprio and Cate Blanchett.

Late physicist Hawking was an acquaintance of Epstein due to their shared academic background. While Jeffrey does mention in an email written to Maxwell about the late physicist participating in an 'underage orgy', it is

important to note that this allegation is not substantiated by any facts so far.

Similarly, the names of Hollywood stars DiCaprio and Blanchett were mentioned as a part of questioning during one of the testimonies. The victim was asked if she happened to have met the celebrities whilst giving a massage to Epstein as press reports suggested that the victim had met them.

Despite former US President Bill Clinton's infamous past, in the context of this case, there has been no concrete evidence incriminating him. It is known that he had visited Epstein's island on several occasions, however, no testimony has been made of him indulging in any 'sexual acts' with minors. The closest thing we have to a testimony is Johanna Sjoberg's (another victim of Epstein) deposition, according to which. Epstein told her, "Clinton likes them young, referring to girls."

# JN. 1 variant may hamper metro finances

BENGALURU: Metro rail services across the metropolitan cities in India, barely one year out of the woods from the pandemic shock, are yet again staring at a loss, thanks to the JN.1 variant of Omicron Covid-19. After posting a modest profit in FY 22-23, they are experiencing sluggish growth in the current fiscal year.

According to the annual reports released by major metro rail corporations such as Delhi Metro, Bangalore Metro and Chennai Metro, they earned profits of 3,389.13 crores, 376.88 crores and
