### 'Ladakh climate fast' urges statehood

wo weeks have passed since the commencement of the Ladakh Climate Fast, which started on March 6. According to Sonam Wangchuk, a renowned innovator and activist, the 21-day fast until death is an attempt by the locals to urge the Central government to look into the issues of environmental endangerment and restore statehood to Ladakh.

The abrogation of Article 370 turned Ladakh into a Union Territory, administered by a Lieutenant Governor appointed from Delhi. However, there is now a pressing demand from the people to implement Schedule 6 of the Indian Constitution. This provision would grant tribal status to residents, enabling them to elect representatives dedicated to safeguarding the fragile ecosystem of the region. Despite repeated promises made by the Central government to address these issues in past election manifestos, on March 4, it refrained from delivering the promise, Wangchuk said on X formerly Twitter.

Speaking to The Beacon, Sonam Angmo, a resident of Photoksar village, has expressed concerns regarding the impact of unregulated industrialisation and the rapid influx of tourists on the Himalayan glaciers. Angmo said that while Ladakhi people have historically lived sustainably, the surge in tourism poses a significant threat, endangering both glaciers and local animal species. "Deterioration of Himalayan glaciers will have nationwide repercussions, as the rivers originating from the Himalayas will dry if the situation is allowed to proceed unchecked," she added.

## Derailments: A major cause of train accidents



erailment from tracks has consistently been the most recurrent cause of Indian Railway accidents. Despite a downward trend in the total number of accidents, the proportion of derailments has only increased. It has become a major threat to travel safety on trains.

On March 18, the Sabarmati-Agra Cantt Superfast Express derailed at Madar, near Aimer. Passengers suffered injuries, however there was no loss of life. This is one of several instances of derailments in the past decade.

Statistics from the Indian Railways Year Books of the past decade reveal that there's been a downward trend in the total number of accidents occurring each year.

In 2013, the total number of accidents amounted to 117, followed by 131 in 2014, which was the highest

number of accidents in the past decade. Ever since then, there's been a gradual decrease with 2023 recording a total of 48 accidents.

However, the proportion of derailments continued increase. In 2013, derailments constituted about 44 per cent of the accidents, which had gradually increased to 75 per cent in 2023. Contrasting it with other causes of accidents reveals that level-crossing-related accidents have drastically reduced over the past decade (from 51 in 2013 to 1 in 2023). However, other causes including, fire on trains, collisions and other miscellaneous causes have fluctuated over the years.

Nonetheless, since 2015, of railway accidents have occurred due to derailments.

Furthermore, a total of 745 railway accidents have occurred in the past decade, out of which 471 were caused due to it.

The budget allocated for track renewals was 17,150 Cr with other safety such measures receiving much less.

Out of the Rs 2.55 lakh crore allocated to the Ministry, Rs 42,539 crore was allocated to ensure safety measures.

Despite the increase of 4.9 per cent from the previous year's budget, safety-related works saw only a 3.5 per cent increase from FY 2023's budget.

Additionally, compared to the previous year, the proportion of budget allocation expenditure on safety remains nearly the same: 16.8 per cent (FY 2023) and 16.6 per cent (FY 2024).

## BBMP unveils 'Tax-First, Khata-Later' property scheme

BENGALURU: Months after mooting the idea, the BBMP announced the launch of the "tax-first, Khatalater" scheme to simplify the property tax system for the people of Karnataka.

The BBMP on March 11, Monday, launched a new scheme that would allow property tax collection even from irregular or unauthorised properties, given that they are not on government-owned land.

The new property tax laws, which were introduced as Section 144 under the BBMP Act, will rise from 6.7%

urder Mubarak, director Homi Adjana's new addition to his cinematic collection, dazzles brightly but fails to enthral for most of its runtime.

Released on Netflix, on March 15, Murder Mubarak is an adaptation of Anuja Chauhan's novel: 'Club You to Death'. The movie boasts an enviable ensemble cast of Pankaj Tripathi, Karishma Kapoor, Sara Ali Khan, Vijay Varma, and several others who hit all the right notes in

The movie is based around a murder investigation that unfolds several dark secrets of members of the elite Royal Delhi Club. The elites are represented as caricatures, parodying their demeanour, which is juxtaposed with the non-frivolous attitude of the servant workers in the club.

places several sub-scenes to elicit this theme.
