BESCOM puts **ASD** into action

BENGALURU: Under the Gruha Jyothi Yojana, the interest on the security deposit is credited to the account of customers who receive zero bills. This interest will be adjusted against future electricity charges once the consumer gets a net bill or non zero bill, said Suraj, (name changed) manager of Bangalore **Electricity Supply Company** Limited (BESCOM) office.

BESCOM has implemented The Additional Security Deposit (ASD) system to manage electricity consumption for its customers effectively based on the annual average electricity consumption.

Speaking to The Beacon, Suraj said, "The ASD of BESCOM is determined based on the electricity demand of new customers. It is not a tax or extra charge. It is calculated based on the customer's annual average electricity consumption."

"At the beginning of the next fiscal year, we examine the average consumption from the previous year. If the average is higher than the demand, the customer will be asked for an extra security deposit; if the average is lower than the demand, the security deposit will be refunded," said Suraj.

The Assistant Executive Engineer (AEEs) is responsible for the respective subdivisions to notify the customers about the additional security deposit. The newly determined security deposit can be paid through BESCOM official website or through BESCOM Mitra mobile app, he added.

Union Budget FY 2024-25 strengthens 'Defence' Sinchan Saha

BENGALURU: The Defence received the highest budget allocation, constituting nearly 13% of the central government's overall budgeted expenditure. The Union Budget for Fiscal Year 2024-25 allocated Rs 4.54 lakh crores for this sector.

The BJP-led National Democratic Alliance (NDA) government introduced its first Union Budget under Finance Minister Nirmala Sitharaman on Tuesday, 23 July. In February, the Interim Budget allocated Rs 6.22 lakh crore for FY 2025, which was slightly lower than FY 2024 revised estimate. This allocation still remains the highest among other ministries.

India's agricultural ministry received Rs 1.52 lakh crore, said Financial Minister Nirmala Sitharaman, while presenting her seventh

consecutive Budget. FM announced her new plan for agricultural upgrade. She unveiled the release of 109 high-yielding and climate resilient varieties of 32 fields and cultivation crops in this financial year.

The agriculture allocation is approximately 26% more as compared to last year's

Rs 1.25 lakh crore. "In the next 2 years, 1 crore farmers will be initiated into natural farming supported bv certification and branding," the FM said.

Under the third term of the Union Budget of the Modi-led government, the standard deduction limit has been increased to Rs

75,000. This would provide more money for the salaried class. Additionally, the FM proposed raising the longterm capital gains tax from 10% to 12.5% in the Budget allocates Rs 2 lakh crores for for 2024-25.

is to be revised, the FM announced. For zero to three lakh rupees, tax rate is

zero. For three to seven lakh rupees, it is five percent. While seven to 10 lakhs is under 10% slab; Rs 10 lakh to Rs 12 lakh is 15%; For Rs 12 lakh to Rs 15 lakh is 20% and for Rs 15 lakh and higher is 30%.

FM Sitharaman allocated ₹1.48 lakh crore focusing on employment, skilling, Micro Small Medium Enterprises and the middle class. This was dedicated to the education, employment and skilling sector. With a need to focus on the poor, women, youth and farmers, the Minister said, the government has extended the PM Garib Kalvan Anna Yojana for five years which is benefiting 80 crore people of the country.

Further, the Budget also job creation, 10 lakh crore The tax rate structure for urban housing and Rs 90, 958.63 crore (increased 12.96% from the interim budget) for healthcare.

On July 23, All India Students Association (AISA) led a march to the Vidhan Sabha demanding re-conduct of NEET, resignation of Education Minister Dharmendra Pradhan, and scrapping of NTA. Tuesday onwards, the Supreme Court continued hearing of over 40



pleas on irregularities related to NEET-UG 2024, and has passed an order to not conduct as it "can't conclude sanctity breached." Several student bodies have announced a parliamentary march in New Delhi on August 9.

The growing instances of malware attacks and cyber threats has made cyber security for Kerala. "Consistent cases in recent years highlight the mishandling of sensitive information and employee negligence to be the major

causes of these breaches," said Shinoj.

Data of around 65 lakh candidates have been leaked from PSC alone. This poses a high risk in the misuse of candidate photos, Aadhaar documents, fingerprints etc.
