# Knowledge and Power in Foucault

...knowledge and power are internally related. Sexuality can become an area of investigation only when power establishes it as such, and at the same time power can operate (to control people) through knowledge of sexuality only after sexuality has been constructed by the sciences. Therefore, the constructs of knowledge and the strategies of power mutually emerge in and through one another... power is dispersed throughout society in all the multitudinous "tactical" power relations between people as individuals. "And 'Power,' insofar as it is permanent, repetitious, inert, and self-reproducing, is simply the over-all effect that emerges from all these mobilities" (HSI 93). In other words, the power of people in the aggregate of classes and institutions emerges as the recurrent patterns and strategies implicit at the individual level. Power grows from the bottom up--from any social relationship in which there is inequality (HSI 93) --and thus suffuses society. (David L Potts, Feb 27, 2011)
